OPTIMIZING THE REFERRAL PROCESS

A guide to referring your patients to a pharmacy



Provide a strong recommendation

If your patient is eligible for a vaccine, your strong recommendation is a good way to help increase follow-through to vaccination.¹



Discuss patient expectations

Set expectations regarding the vaccine and walk patients through the process in clear language.

This includes:

- How it can help prevent shingles
- Information on administration, dosage, and potential adverse effects



Support your recommendation

Providing tangible information, including educational materials, or a prescription or eScript may encourage patients to take the next step toward vaccination.¹



Confirm vaccination appointment

Using a retail pharmacy app or the SHINGRIX vaccine scheduler to schedule appointments is a simple, efficient way to help ensure patients are getting vaccinated.



Follow up

Confirm and document their vaccination at your patient's next office visit to help reinforce the urgency of protection against shingles.¹

Indication

SHINGRIX is a vaccine indicated for prevention of herpes zoster (shingles) in adults aged 50 years and older.

SHINGRIX is not indicated for prevention of primary varicella infection (chickenpox).

Important Safety Information

- SHINGRIX is contraindicated in anyone with a history of a severe allergic reaction (eg, anaphylaxis) to any component of the vaccine or after a previous dose of SHINGRIX
- Review immunization history for possible vaccine sensitivity and previous vaccination-related adverse reactions. Appropriate medical treatment and supervision must be available to manage possible anaphylactic reactions following administration of SHINGRIX
- In a postmarketing observational study, an increased risk of Guillain-Barré syndrome was observed during the 42 days following vaccination with SHINGRIX

A PRESCRIPTION

While not needed, an eScript or prescription is a helpful reminder to patients

Important Safety Information (cont'd)

- Syncope (fainting) can be associated with the administration of injectable vaccines, including SHINGRIX. Procedures should be in place to avoid falling injury and to restore cerebral perfusion following syncope
- Solicited local adverse reactions reported in individuals aged 50 years and older were pain (78%), redness (38%), and swelling (26%)
- Solicited general adverse reactions reported in individuals aged 50 years and older were myalgia (45%), fatigue (45%), headache (38%), shivering (27%), fever (21%), and gastrointestinal symptoms (17%)
- The data are insufficient to establish if there is vaccine-associated risk with SHINGRIX in pregnant women
- It is not known whether SHINGRIX is excreted in human milk. Data are not available to assess the effects of SHINGRIX on the breastfed infant or on milk production/excretion
- Vaccination with SHINGRIX may not result in protection of all vaccine recipients
